Changes to Rule 2013-14

7 of the proposed amendments to rule received the required number of votes:

- 1. Allow Coloured clothing in all junior cricket (tops only)
- 2. Form an official U9's Friendly League.
- 3. Have fixed dates for U9's and U11's Fixtures but if not played on the original date, the fixture can be rearranged for another date by agreement of both teams playing.
- 4. NO OPTION to opt out at any Junior age group, but you enter a 'RED' team in your chosen 'struggling' age group which will complete fixtures and be played on a flexible friendly. U9's, U11's, U13's U15's and U18's
- 5. U18's Add rule" In the event of teams having an equal number of points, the order of merit shall be decided according to the ratio of runs per wicket scored divided by runs per wicket conceded, over all Two Day League matches played, (Highest ratio first)"
- 6. A District or Interleague player may only Transfer to a club (were a district or Interleague Manager is a member), when the transfer form is signed by the LCB Cricket Co-Ordinator (Bolton) for district cricket and the age group Secretary for Interleague.

Junior section

Notes on Income and Expenditure

The dates on which the junior presentations were hosted in 2011/12 meant that 2 presentations were held in the same accounting period in 2012. This is why there are no comparative figures against the 2011 presentation.

The 2013 presentation generated income from tickets sales and club donations of £918 compared to the cost of trophies and food which amounted to £1,184. An overall loss of £265 was therefore made.

The league did not acquire any coaching mats in 2013 hence the reduction in this income stream compared to 2012.

Course income in relation to Safeguarding and First aid were slightly down on last year. Since the year end the league has received approximately £700 in income from clubs outside the BCL for courses. This is however, to be offset against the cost of the courses from the LCB. Both the income and the costs will appear in the 2014

Sales of junior balls were down on 2012 but the league has no control on the number of balls being ordered and therefore sold to clubs. The cost of these balls was £2,415 compared to sales of £2,226. The difference being balls ordered for use by junior interleague sides which are not passed onto clubs.

As in previous years each club has been invoiced £100 in order to cover some of the costs incurred by the junior section.

Overall the junior section has generated a surplus in the period of £308 and has cash in the bank of £2,401.
